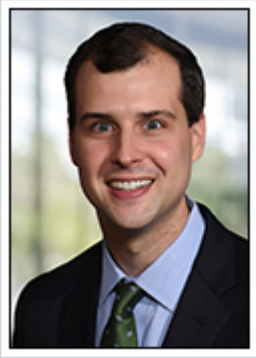
### **Jim Crawley**
